

Terms & Conditions

Effective Date: June 2025

1. Acceptance of Terms

By accessing and using btfpropfunding.com (the "Platform"), you agree to be bound by these Terms & Conditions. If you do not agree with any part of these Terms, you must not access or use the Platform.

2. Description of Service

BTF Prop Funding is a proprietary trading firm that provides:

- Simulated trading environments and demo accounts
- Trading evaluations and performance-based programmes
- Educational resources and analytics
- Access to third-party trading platforms and tools

All trading activity takes place in a **simulated environment using demo accounts**. No real-money trading, brokerage services, or investment management is provided. BTF does not manage client funds and is not a licensed financial institution.

3. User Eligibility

To use our services, you must:

- Be at least 18 years old
- Have legal capacity to enter binding agreements
- Not reside in jurisdictions subject to FATF, EU, or UN sanctions
- Provide accurate, truthful, and complete registration information
- Not be a citizen or resident of any jurisdiction where such services are prohibited

4. Account Registration and Security

By creating an account, you agree to:

- Provide and maintain accurate and current information
- Keep your login credentials secure and confidential
- Be fully responsible for all activity on your account
- Notify us immediately at support@btfpropfunding.com of any unauthorized access or security breach

5. Programme Participation and Fees

Participation in BTF Prop Funding programmes is voluntary and subject to:

- Payment of applicable programme fees prior to account access
- Compliance with all published trading rules and guidelines
- Meeting performance targets and evaluation criteria
- Adherence to defined risk management parameters

Programme fees are used for operational costs, including technology, staffing, platform access, and business operations. **Fees are not deposits, investments, or refundable trading capital.** Please refer to our Refund Policy for full details.

6. Trading Rules and Guidelines

All participants must comply with programme-specific rules, including but not limited to:

- Maximum daily loss limits
- Maximum overall drawdown limits
- Prohibited trading behaviour or strategies
- Minimum trading day requirements
- Profit consistency rules (where applicable)

Failure to comply with any rule may result in immediate account termination without refund. Specific rules for each programme are published in the Trader Dashboard.

7. Instruments and Trading Hours

BTF Prop Funding supports trading in the following instrument categories:

- Forex currency pairs (major, minor, and exotic pairs)
- Cryptocurrency derivatives (including BTC, ETH, and other supported digital assets)

Permitted trading hours, available instruments, and any news-event restrictions are published in the Trader Dashboard for each programme. Trading outside permitted hours or on restricted instruments may result in account disqualification.

8. Funded Accounts

Upon successful completion of all evaluation phases, BTF will grant the Trader access to a simulated funded account. The following conditions apply:

- The Trader must sign a separate Trader Agreement before funded account activation
- Profit split percentages are defined in the Trader Agreement (typically 70%–90%)
- Profit withdrawals are subject to the schedule and conditions in the Trader Agreement
- BTF may offer account scaling to consistently profitable Traders
- All funded account trading remains in a simulated environment using virtual capital

BTF reserves the right to modify funded account conditions with reasonable notice. Continued use of the funded account constitutes acceptance of updated conditions.

9. Intellectual Property

All content, branding, software, features, and materials on the Platform are the exclusive property of BTF Prop Funding and are protected under applicable intellectual property laws. You may not copy, distribute, modify, or create derivative works without prior written permission from BTF.

10. Prohibited Conduct

You agree not to:

- Use the Platform for any unlawful or fraudulent purpose
- Manipulate, exploit, or abuse platform systems or price feeds
- Share, sell, or transfer account access to any third party
- Use unauthorized automation, bots, or algorithmic exploits not permitted by BTF
- Engage in latency arbitrage, tick scalping, or copy trading between affiliated accounts
- Exploit platform errors or technical glitches to generate artificial profits
- Engage in deceptive, fraudulent, or abusive behaviour toward BTF or other users

- Violate any applicable laws or regulations

BTF reserves the right to determine, at its sole discretion, whether conduct violates these prohibitions. Violations result in immediate account termination without refund.

11. Disclaimers

- All accounts are simulated demo accounts — no real capital is traded
- Past evaluation or trading performance does not guarantee future results
- No financial, investment, or trading advice of any kind is provided
- Trading in Forex and cryptocurrency markets involves substantial risk of loss
- We do not guarantee profits, evaluation success, or funded account continuation
- Market conditions, technical failures, and other factors are outside BTF's control

12. Limitation of Liability

To the fullest extent permitted by applicable law, BTF Prop Funding shall not be liable for any indirect, incidental, consequential, special, or punitive damages, including loss of profits, data, or business opportunities resulting from your use of or inability to use the Platform. BTF's total aggregate liability shall not exceed the amount paid by you for the specific programme giving rise to the claim.

13. Indemnification

You agree to indemnify and hold harmless BTF Prop Funding, its directors, officers, employees, and partners from any claims, losses, liabilities, or expenses (including reasonable legal fees) arising from:

- Your use of or access to the Platform
- Your violation of these Terms & Conditions
- Your breach of any applicable law or regulation
- Any third-party claim related to your account activity

14. Termination

We reserve the right to suspend or terminate your account immediately and without prior notice if we determine that your conduct violates these Terms, harms the Platform, other users, or the integrity of our business operations. Upon termination for breach, no fees will be refunded.

15. Governing Law

These Terms are governed by and construed in accordance with the laws of the **Czech Republic**, without regard to conflict-of-law principles. Any disputes arising under these Terms shall be subject to the exclusive jurisdiction of the competent courts of the Czech Republic. The parties agree to attempt resolution through good-faith negotiation for a period of 30 days before initiating legal proceedings.

16. Changes to Terms

We may update these Terms at any time. Any changes will be posted on this page with a revised effective date. Continued use of the Platform after changes are posted constitutes your acceptance of the updated Terms. We will notify you of material changes by email.
